Rates for Pool Parties:

These rates are for use of the pool, playground, and furniture on the pool deck only. There is a different contract and procedure for rental of the clubhouse. Hosts may use the refrigerator in the old snack bar area to store any food. Please make sure the manager on duty receives your signed contract and check (if you're paying that way) upon arrival.

- 2 hours, up to 25 non-member guests: \$175 to include one lifeguard dedicated to your party
- 3 hours, up to 25 non-member guests: \$200 to include one lifeguard dedicated to your party
- 2 hours, 25-45 non-member guests: \$250 to include two lifeguards dedicated to your party
- 3 hours, 25-45 non-member guests: \$300 to include two lifeguards dedicated to your party

Please initial your agreement to the following stipulations:

[] PARKING LOT: Northbrook Country Club is not responsible and shall be held harmless and indemnified for damage to vehicles while parked in our parking lot or for articles that are lost or stolen while on our premises. Guests parking in areas other than designated for parking do so at their own risk.

[] INDEMNIFICATION: The renter agrees to indemnify and hold harmless Northbrook Country Club, its employees, membership and board of directors from any claims arising out of the use of Northbrook Country Club by renter and/or their guests.

[] CLUB RULES: Renter agrees to abide by and ensure party guests abide by all Northbrook policies and rules in effect at the time of rental. Renters understand that there is to be NO GLASS of any kind in the pool or on the pool deck.

RELEASE OF LIABILITY

I, the Renter, fully understand that Northbrook Country Club, the Northbrook Board of Directors, and the Northbrook membership are not responsible for accidents or injuries to the Renter or their guests. I understand that any damage done to the facility is my responsibility. I agree to indemnify and hold Northbrook Country Club, its Board of Directors, Employees, and Members harmless for any damages sustained. I agree to leave the facility clean and in good condition.
